## Call for Papers

We are pleased to announce that the *Barishal University Law Journal* (ISSN: 2411-247X) is inviting original research papers to consider for publication in its first issue (Volume I, Issue I) in 2020.

The Journal is supposed to be published twice in a year by the **Faculty of Law, University of Barishal** with the aim to promote publication of pragmatic researches in the various aspects of law, contemporary legal issues, and other allied disciplines. Research papers on interdisciplinary issues related to legal fields, theories and philosophy will also be considered for publication in the Journal.

### **Instructions and Guide for the Authors**

1. Papers that have been previously published or are currently under consideration for publication anywhere else shall not be considered for publication process. The author shall be held liable for such cases.
2. For publication, each paper has to comply with the **Editorial Policy** of the Journal attached herewith. For the purpose, each paper shall be internally reviewed first and if found primarily worthy of publishing shall undergo a blind peer review process. However, submitted papers are also subject to any posterior changes brought to the Editorial Policy.
3. Only the papers suggested by the reviewers for publication will be considered for publication after ensuring required corrections, modification and alteration if any.
4. Language of the paper shall be either Bangla or English and should be extended to maximum 10,000 words excluding notes and references.
5. The English font must be Times New Roman with 12 size, be spaced at least 1.5 and the paper written in Bangla shall be in 14 font size and spaced at least 1.5. Printed copies must be typed on one side of A4 size papers with margins 1.5 inch on the left side and 1 inch on the right.
6. Papers must be in OSCOLA, 4<sup>th</sup> Edition as attached herewith. For support the authors may refer to the authentic resources on [OSCOLA 4th Edition](https://www.law.ox.ac.uk/sites/files/oxlaw/oscola_4th_edn_hart_2012.pdf) and also may visit the website/link-

- a. Two printed copies along with a soft copy of each manuscript shall have to be sent to the Associate Editor of the Journal;
  - b. The manuscript to be submitted shall contain an abstract of maximum 150 words with keywords placed just after the title of the Paper;
  - c. The cover page of the manuscript shall contain the title of the paper, name/s and professional identity of the author/s, specifying the corresponding author, with phone numbers and e-mail id.
  - d. A certificate of declaration containing that the paper has not been published or submitted elsewhere for publication.
8. Each author shall get two copies of the concerned issue of the Journal. The journal authority will send those copies by general post to the author/s correspondence address.
  9. Not more than **two papers of an author**, as the first author or as a co-author whatever the case may be, shall be considered for publication process for the same issue. However, if any author submits more than one paper, as the single author of each paper, for a single issue only the paper received first shall be considered for publication process.
  10. Most pertinently, **plagiarism** shall strictly be dealt with and if any paper is found plagiarized of any kind and at any degree the Journal authority shall take appropriate steps against the concerned author/s.

## Editorial Policy

### Preamble

The editorial policies hereinafter provided are to be complied with, by the authority and the Editorial Board of the Barishal University Law Journal, as far as possible in order to ensure authenticity of scholarship, quality and uniformity of publication, commitment of the Faculty of Law to furthering legal knowledge.

### Publication and Subject Matter

1. Papers to be considered for publication in the Barishal University Journal of Law shall have to be a piece of original research work conducted by the author/s and should make a contribution to the advancement of existing knowledge either by the discovery of new facts and theories or fresh interpretation of known facts and theories.
2. Papers that have been previously published or are currently under consideration for publication anywhere else shall not be considered for publication in this Journal.
3. The Journal will promote publication of pragmatic researches in the various aspects of law, contemporary legal issues, and other allied fields. Research papers on socio-legal issues and interdisciplinary issues related to legal fields, theories and philosophy will also be highly considered for publication in the Journal.
4. The issue/s published in a year shall constitute a Volume of the Journal. There may be periodic regular issues as well as special issues in a volume but at least two issues will be published in a year/volume.

### Submission and Correspondence

5. Manuscript may be submitted to the Editor or the Associate Editor, as the Editor decides, of the Journal at any time throughout the year and the papers received so will be considered, as far as possible, for publication process of the forthcoming issue.
6. If any paper submitted is produced by more than one author the author whose name appears first in the paper shall be regarded as corresponding author unless otherwise is indicated in the cover of the paper submitted.

7. The Corresponding Author shall be responsible for all official communications with the Journal Office as well as for complying with the rules and requirements set by the journal authority, the Editorial Board and the reviewer/s.
- Review and Editing**
8. Each article shall be internally reviewed first by the Editorial Board and if found primarily worthy of publishing shall undergo a blind peer review process.
9. Only the papers suggested by the reviewer/s may be considered for publication, after ensuring necessary corrections, alteration and editing, if any.
10. The correspondent author shall be responsible for making any corrections, modifications, editing, etc. as required by the reviewer/s and the Editorial Board.
11. The Editorial Board shall have full authority of editing any paper up to a reasonable degree only for the purpose of ensuring compliance of this Editorial Policy.
- Language and Style**
12. Language of the paper shall be either Bangla or English and should be extended to maximum 10,000 words excluding notes and references. British language style and rules should be followed if the paper is written in English.
13. The English font must be Times New Roman in 12 size and be spaced at least 1.5 and the paper written in Bangla shall be in 14 font size and spaced at least 1.5.
14. Papers must be in OSCOLA, 4<sup>th</sup> Edition. submits more than one paper, as single author of each paper, for a single issue only the paper received first, unless otherwise is preferred by the author/s, shall be considered for publication process.

# OSCOLA Quick Reference Guide

## Primary Sources

Do not use full stops in abbreviations. Separate citations with a semi-colon.

### Cases

Give the party names, followed by the neutral citation, followed by the *Law Reports* citation (eg AC, Ch, QB). If there is no neutral citation, give the *Law Reports* citation followed by the court in brackets. If the case is not reported in the *Law Reports*, cite the All ER or the WLR, or failing that a specialist report.

*R (Roberts) v Parole Board* [2004] EWCA Civ 1031, [2005] QB 410

When pinpointing, give paragraph numbers in square brackets at the end of the citation. If the judgment has no paragraph numbers, provide the page number pinpoint after the court.
